CUSTOMS REGULATIONS - PORTUGAL

- SHIPMENTS ARRIVING FROM EUROPEAN COMMUNITY COUNTRIES:



DOCUMENTS REQUIRED:

- A) BY TRUCK Packing list and CMR
- B) BY AIR..... Packing list and photocopy of the passport, AWB
- C) BY SEA Packing list, photocopy of the passport, OB/L & T2L
- **CARS, MOTORBIKES, BOATS:** Original title of property and registration card with the driver (by road), by sea; please send the originals with T2L & OBL by courier to our care.

- SHIPMENTS ARRIVING FROM OTHER COUNTRIES, OUTSIDE EUROPEAN COMMUNITY :

- A) "CONSULATE CERTIFICATE " with packing list attached (written in Portuguese) with no values described, issued by the nearest Portuguese Consulate; we recommend the client don't mention 2nd residence in this certificate (if any)
- B) "RESIDENCE CERTIFICATE" (Atestado de residencia) obtained by client at the "Junta de Freguesia" of his residence in Portugal, stating that he has been residing there for less than one year and mentioning also the date of his arrival.
- C) Original or certified copy of his passport (Can be done by Portuguese consulate at origin)
- D) Photocopy of VAT card (Cartão de contribuinte)
- E) Working Visa (For foreigners, non EEC citizens)

OTHERS:

- **CARS, MOTOR BIKES, BOATS:** Original title of property and registration card must be in possession of the owners at least 6 months before arrival in Portugal; Portuguese or EEC citizens must issue a separated "certificate of baggage" only for the car.
Only 1 car allowed, 2nd car if any will pay duties
- **PORTUGUESE DIPLOMATS:** Apply same documents as described above;
- **FOREIGNER DIPLOMATS:** (Non Portuguese) Embassy of his country in Portugal must obtain a Diplomatic Franchise from the Portuguese Ministry of Foreign Affairs, before arrival of vessel in order to avoid delays at pier.
- **PETS:** Bloody exam with certificate of healthy issued by a certified veterinarian, insertion of microchip, pet passport with vaccinations in order.
- **INHERITANCE:** Certified copy of death certificate and will, allow duty free entry.
- **GUNS:** Property title, certified issued by Portuguese Consulate, must be declare on certified of baggage (Only hunt and civilian guns allowed)
